Transformation Readiness Assessment

Assesses the readiness of your community to move to new enterprise information solutions.

Identity and Access Management (IAM) Strategic Plan and Roadmap & IAM Vendor Evaluation

Institutions undertaking an ERP replacement will have to address Data Quality throughout the project, otherwise they will jeopardize the go-live and/or risk the quality of future reporting. In this tool, we work with you to put together an approach to kick-off a Data Quality project.

ERP Implementation Strategy and Timeline

Develops a consensus across stakeholder groups on the best implementation approach and timeline for deploying the new ERP and develops an ERP Implementation Governance Model that incorporates broad participation and strong project decision-making support.

ERP Implementation Staffing Model

Develops a proposed Staffing Model that includes technical, functional and project management roles.

ERP Business Case Development

Provides a Business Case Analysis on the benefits, risks, implementation roadmap, and cost impacts of implementing new ERP software.
